Funding for Tri State Farm Marketing Conference Approved

The Office of the Commissioner of Agriculture has notified Historic Hoosier Hills that the application for a USDA Block Grant to provide seed money for a Tri State Farm Market Conference has been approved. The funding should be available later this summer. The grant proposal was fully funded at \$10,000.

Historic Hoosier Hills made application on behalf of several partners who are working together to create a two-day conference to bring specialty crop producers for Indiana, Northern Kentucky and Southwest Ohio together. Goals of the conference are to get producers together to share ideas and information, and to begin creating market sharing opportunities between states to extend the market season in all three states.



The conference is being planned under the Southern Indiana Rural Development Project (SIRDP) with numerous partners helping with the planning and conducting of the program. Indiana partners include the Indiana Farm Bureau, Purdue Cooperative Extension Service, Madison Area Small Business Development Center, USDA Rural Development, and Historic Hoosier Hills. Kentucky partners include the Kentucky Commodity Growers Cooperative (which includes some southeastern Indiana counties), and the University of Kentucky. Our Ohio Partner is the Miami Valley RC&D in southwest Ohio. In addition, Heifer Project International and the National Farmers Union have committed funding in support of the conference.


Final plans for the conference will be made this summer, with the conference taking place in January or February. The conference will be well advertised once final arrangements are complete.

The Jennings County Growers Cooperative, a project committee under Historic Hoosier Hills, also received most of its funding request through the USDA Block Grant Program. Their proposal involves establishing an education and market development program for specialty crop growers in Jennings County. The program they develop will have application in southeastern Indiana and state wide once it is completed. David Swaim, formerly the Program Coordinator for the "Ways to Grow" Program, will serve as parttime staff for the project to help the Co-op Board achieve their goals through the initiative. The program will include educational seminars, workshops and field days; area information resources center; and individualized planning assistance for producers. The project will also assist with market infrastructure planning and development, and assessing feasibility of value-added processing for specific crops.

Ripley County to Open Farmers Market

Saturday, July 27 will be the opening day for the new Ripley County Farmers Market at the Ripley County Fairgrounds at Osgood. The market will be open from 8:00 A.M. to

1:00 P.M. Saturdays and 4:00 P.M. to 7:00 P.M. Wednesdays after July 27th. The market is sponsored by Ripley County Farm Bureau, the Ripley County Parks Department, Ripley County Tourism Bureau, and the County Commissioners. Historic Hoosier Hills has been assisting with planning help.



fourth year. Bud Beesley, first Market Master for Jennings County, met with the Ripley County group and provided some excellent guidance in getting started. Darla Westerfeld, Director of the Ripley County Parks Department, will serve as Market Master for this first year. The group plans to host a meeting this winter of all producers who sell at the Ripley County Market and invite them to elect their own Directors, set their own rules, and select their own Market Master after this first year. The market will then be operated and overseen by those who use it most.

Area vegetable producers re invited to participate – there is no charge to set up and sell at the market. Vendors must grow 100% of what they sell, and are responsible for complying with all local and state laws regarding the products they sell. Oak Heritage Conservancy Elects First Officers, **Adopts Bylaws**

The Oak Heritage Conservancy, a new Land Trust organized under Historic Hoosier Hills earlier this year, elected their first officers at the June meeting. The group has been focused on organization and structure since its first meeting late last fall. John Miller was elected President; Dr. Daniel Webster was elected Vice President; Brian Lowry was elected Secretary; and Paul Carmony as Treasurer. All officers will serve for the balance of 2002.

The group also finalized and adopted their Bylaws at the June meeting. Their first Board of Directors is set, with Directors including the officers plus Dr. Bob Mulford, Daryl Karns, Cliff Chapman, and Beth Black. Dr. Joe Robb with the U.S. Fish and Wildlife Service is serving as technical advisor. Several other southeastern Indiana individuals are assisting with the development of the land trust as well.

The group's focus is on providing a vehicle for landowners who want to preserve and protect their land long-term from development or conversion to other non-rural uses. They will cover nine counties, including all of Historic Hoosier Hills except Franklin, and including Washington County outside the Historic Hoosier Hills area.
